#### 6. Town Roads

- a. Specify body options for new Town truck (*for delivery in Autumn '23*)
  - various custom options were decided by Steve S. and Steve Z, including:
    - stainless lines w/short hoses - levers to be placed in same sequence as current truck
    - add professional grade reflective tape on dump body - add pintle plate & rear hitch
    - opted out of a broom attachment
- b. Second round of roadside mowing; autumn brushing  
*Motion by Steve Z./Steve S. to re-hire King Clearing Co. for a second seasonal roadside mowing (to be done around Labor Day), and to brush-mow the west 1/3 of township this autumn.* — Carried
- c. Gravel work, equipment needs, signage, Town Hall maintenance
  - recently received fire numbers are being installed • Town Hall grounds cleanup going well; Board agreed to have Mark Tainter continue the project; we’ll bring in crushed rock, black dirt
- d. North Potato Lake Road re-build — place ad for bids
  - Steve Sty has marked all areas that bidders need to assess • Steve S. and Steve Z. listed the various jobs to be done there this season • Board determined deadlines, terms
  - Lisa will write up bid; Anne to place in papers weeks of Aug. 24<sup>th</sup> and Aug. 31<sup>st</sup>
- e. Hogback Road — status of BIL awards; *Plan B* for rebuilding
  - BIL website states now that awarded projects should be announced in month of September
- f. Heller Road improvement — update • No news; no recent contact with Mr. Heller about it.
- g. Park Court discontinuation — update
  - Lisa’s call to DNR’s Water Regulation & Zoning Dept. re: the discontinuation of a lake access point was un-returned; she’ll email them next.
