To consider the adoption of a resolution by the town meeting endorsing a Town Board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2016 by four percent which would be a dollar increase of \$8,000.00 2.
